benchmark for each learning outcome is that *70% of students will meet or exceed outcome criteria.*

#### SEQUENCE OF TOPICS:

1. The sequence of activities will be different each semester and entirely dependent on the repertoire to be learned.
2. The instructor will select the repertoire. Each semester the focus of the course will be different. Possible themes may include (but are not limited to):
  - a. Music of Dufay and his contemporaries
  - b. Music of Joaquin and his contemporaries
  - c. Music of Palestrina and his contemporaries
  - d. Survey of the Italian Madrigal
  - e. Music of Monteverdi and his contemporaries
  - f. Late Baroque a cappella repertory
  - g. 20<sup>th</sup> century a cappella repertory
